8. Items for Discussion and Resolution

8.1 Labor's Budget is a budget for the rich

Motion: That the Curtin Student Guild:

- Condemns Labor's May budget for hanging students, workers, welfare recipients, and people with disabilities out to dry as the cost of living pushes living standards down every day, while giving handouts to the rich

- Notes that the Government received advice from independent reviews, lobbying groups, and unions that the cost of living crisis needs serious, immediate action, and still chose not to provide substantial relief

- Condemns the deliberate ignoring of the needs of vulnerable people, particularly when it is in favour of worthless splurging on submarines and billionaire tax cuts

Moved: Danica Scott (Ordinary Representation Board member) Seconded: Rey Nairn (Accessibility Officer) Carried

Danica Scott said that the budget was a travesty. The Stage 3 tax cuts would cost \$3 billion. Danica said that the budget did not increase welfare payments enough. Polite negotiation Did not work. Rey Nairn talked about NDIS funding noting that there was a need to analyse what was behind the growth in NDIS demand. Rey said that it was important to support the vulnerable. Dylan Botica said that the Federal budget was inadequate. Dylan said that the Guild had put out a media statement. Dylan said lobbying had produced incremental results. Danica Scott advocated involving students in campaigns. Veronika Gobba agreed with the motion. Ryan Kirby said the budget was disappointing. There was a discussion about the priories of the Federal Government. Mitch Craig said that lobbying for an increase to the HDR stipend had worked with Curtin one of the first universities to increase its stipends.

Dylan Botica said WA Uni Review submissions were due on Monday. Dylan had lobbied for inclusion and a meeting with the panel to be on the same footing as the VCs.
