 - 8. Items for Discussion and Resolution
- 8.1 Curtin Student Guild Stands in Solidarity with Palestine

Motion: That the Representation Board approve the following policy on Israel-Palestine matters:

The Curtin Student Guild:

- stands against the Israeli occupation of Palestine and condemns the ongoing ethniccleansing of Palestinians
- supports the self-determination of the Palestinian people and their right to engage in self-defence against their occupiers
- deems the use of Zionism to justify the illegal occupation of Palestine as racistandcolonial
- recognises that Israel is an apartheid state in accordance with prominent human rights organizations like Amnesty International, B'Tselem, and Humans RightsWatch.
- opposes the adoption of polices that prohibit criticism of Israel by Curtin University, including aspects of the IHRA definition of antisemitism
- condemns any and all forms of antisemitism and notes that the actions of the Israeli Government have been used to fuel anti-Jewish hatred.
- notes that Israel's actions are not representative of the Jewish community. Similarly, Israel's crimes are its responsibility alone and not that of Jewish people worldwide.

The Representation Board recommends to the Guild Council that it adopt the following resolution:

The Guild Council approves a boycott on companies that support and profit from the Israeli apartheid in line with the global BDS guidelines and create a register for all staff and Officers that lists 'boycotted companies'. The register's maintenance is to be delegated to the President.

The Representation Board will enact the associated actions in full.

Dylan Botica spoke to the motion saying that the Guild had long supported the Palestinians who were under occupation of the Israeli Government. Dylan said it was appropriate that the Guild take a formal stance on the issue. Dylan said it was important that Guild Council take active steps to boycott companies that were supporting or providing money to Israel. Dylan talked about the suffering of the Palestinian people, the IHRA definition of antisemitism and the coverage by the media. Jude Soussan spoke to the motion noting the VC's emails to students about the conflict did not acknowledge the impact to Palestinian students on campus. Aleena Shaji said that while she supported the motion she wanted to confirm that the Guild was not supporting the actions of Hamas, that they were different from the Palestinian people. The Guild did not condone the killings of all innocent civilians. Dylan said that he supported removing point two so as avoid the risk of undue focus on that section rather than the Guild's support of the Palestinian people. Jude was in favour of removing point two.

The Chair Hannah Northey noted the motion removing point two. There were no other changes.

8.2 Curtin Student Partnership Agreement 2024

Motion: That the Representation Board recommend that the Guild Council Approves the 2024 Curtin Student Partnership Agreement and the renewal of the Agreement.

Veronika spoke to the motion noting the changes made to the agreement. Veronika said that the Guild needed to be recognised as the peak student body. Mitch Craig said the final document was much better than what the university had in mind. Rey Nairn raised an area of the document under collaboration and the partnership principle that they said should have Guild added for clarity. There was discussion that the Guild should have a standing invitation to the University Council. Legislation would not need to be changed for that to occur. Guilds of all other WA universities did this. Dylan Botica said that Guild representatives did not have the time to be involved in everything. Motion carried with discussed amendments.

8.4 Demand Curtin make its military ties publicinformation

Danica Scott spoke to the motion noting the event had become very corporate and was out of line with the tradition of Pride marches. Aleena Shaji read comments from Imari Morris who while understanding and agreeing with the overall ideas and sentiments of the motion had concerns that the timing of the protest, the ambiguity of its objectives and some of its focus areas which could confuse people, especially the general public and the media. There was discussion about the motion's reference to the corporatisation of Pride.

Danica Scott spoke about the amendments to the Guild's constitution and wanted it recorded that these changes made the Representation Board less democratic as it was impossible for any minor parties or independents to be a member of the committee. Dylan Botica spoke about the change that would allow any member of the Curtin student community to put forward a motion.
