# 4. Minutes of the Previous Meeting and Circular Resolutions

#### 4.1. Previous Meeting Minutes

# 5. Reports

5.1. President. As tabled. Dylan Botica responded to a question about meeting with the NTEU saying that the union now supported the revised EBA it would go to a staff vote. The EBA had provision for converting casuals to permanent employees, the pay increases were significant. First Nations targets were retained. There was a question about academic calendar review. Dylan said changes were unlikely before 2026. Now there was staff support and some management support. Guild condensed scope of review. Review process had not started yet. Have Guild representatives were on committee. Dylan noted that the IGA liquor license objection timeline could be a few months. Appeal likely and then the issue could take 6-12 months to resolve.

- 5.2. Vice President Education. As tabled. No questions.
- 5.3. Vice President Activities. As tabled. Athina Hilman noted the success of O Day.
- 5.4. Secretary. As tabled. There was a query about procurement policy and/ or gift policy.
- 5.5. Managing Director. David Luketina provided an update on club numbers. There were 85 registered clubs and 14 clubs partly registered. There was a question asked about cost of consumables. David said there had been increasing costs associated with produce and cost of goods and the only practical thing was to increase prices. It was noted that the new Vice President Sustainability could look at whether we should have plates instead of single use items.

There was a question about G Mart and food labelling and listing of ingredients as per the direction of the Victoria Park Council. There was discussion about halal options at the Lolly Wall. Mitch Craig asked about the Basement incident. David Luketina spoke about incident review process. In this incident the investigation concluded nothing could be improved. David noted the waffle machine incident could potentially have been picked up. It had been remedied.

#### 6.2. Amendments to Guild By-Laws 2022

#### EC#56/2023

Motion: That upon the recommendation of the Legal Committee, that the Guild Council approve the amendments to the Guild By-Laws 2022.

Moved: Jasmyne Tweed (Secretary) Seconded: Dylan Botica (President) Carried.

Changes to affirmative action were explained. Changes to the process for a club to be resolved were discussed. This action was to be taken as a last resort. Dylan Botica explained the ways in which a club could be dissolved. Dylan requested to change wording to issue an infringement. Jasmyne Tweed was amenable to amendment. It was noted that the

Remuneration Tribunal would be published before nominations open.

#### 6.3. **Revised Clubs Charter**

Motion: That the Guild Council approves the attached clubs charter. Moved: Dylan Botica (President) Seconded: Jasmyne Tweed (Secretary)

Submitted by David Luketina to simplify the charter noting the original was too complex. High level governance principles were included. Nothing had been added to the charter. David Luketina asked for clarification about political parties and faith-based clubs as the criteria applied was inconsistent. Jacquie Bicanic asked about communications. Athina Hilman said clubs should have been notified first. David Luketina said that the Guild Council could request that this goes to clubs for feedback. Rey Nairn spoke faith-based requirements. Rey said political parties had restricted requirements. Dylan Botica said AEC did not enforce rules and that there were looser governance requirements for political clubs. Athina Hilman spoke about original club charter. Athina would like amendment to bring it back to Guild Council. Dylan Botica highlighted the need for a clause about psycho social obligations.

Dylan moved to withdraw the motion.
