### 4. Items of Significance

### 4.1. University Sustainability Strategy

On the 15<sup>th</sup> of September, I met with Rocio Bona, the Director of Planning for Properties at Curtin to discuss the university's sustainability strategy moving forward.

This is particularly exciting as the initiative to build a sustainability strategy originated from Guild representatives raising the issue of climate change and the need for Curtin to divest from fossil fuels in 2019.

At this stage, we're looking at the consultation process for building the strategy. I have raised the time sensitivity of the situation and am looking forward to contributing. The strategy will cover the physical environment of the university, as well as looking at the research and collaborations we take on and pursue.

### 4.2. WASM Consultation

I met with Melinda Mees, the President of the WASM Student Guild to discuss strategies for pushing back against staff cuts on the Kalgoorlie campus. WASM has undergone a number of devastating change management proposals in recent years and it's important for the Guild there to be equipped with the skills to push back when needed.

We discussed strategies and outcomes for a mini campaign on the Kalgoorlie campus that included petitions, postering, and spreading information, as well rallying.

The Guild at Bentley will support any action to push back against staff cuts at WASM.

#### 4.3. Guild Elections

The Curtin Student Guild election period for 2020 has officially closed. Due to the exception circumstances of this year, we trialled a number of new elements including a new voting location at Clubs HQ, a digital (in person) voting process rather than paper ballots, as well as decreasing the number of booths from two to one.

I would like to extend my congratulations to the successful candidates and all those who participated in this important event.

### 4.4. Academic Support

After meeting with the Vice Chancellor and DVC-A, we can now confirm that the Opt-In Ungraded Pass will be available for Curtin students in Semester 2, 2020. In that same meeting, we raised the Guild's official stance in opposition to the staff redundancies being proposed, citing the impact on student support and quality of education of staff cuts.

I also raised this at Academic Board on the 24th, talking to the wellbeing of staff and students and the impacts on quality of education once more.

### **Curtin Staff Cuts:**

Curtin University has announced plans to reduce its staff bill by \$41 million, with the first \$11 million coming from a deferral of staff pay increases next year and the rest coming from voluntary or forced redundancies.

6482 Curtin staff voted and 56.4% said they are **against** the forgoing of their much deserved pay increase in 2021. Staff working conditions are student learning conditions and we will continue to support staff and fight against job losses.; Our message to Curtin staff is: we see you and hear you, we will stand by your side as your students and fight for your working environment to be a safe and secure one.

Not only does this plan see the university maintain its surplus cash reserves, but its \$80 million library refurbishment plan will also continue. In fact, the university will only be making \$4 million worth of changes to its planned capital works. Potential course cuts and restructures to schools have also been proposed.

The Guild believes that universities should be places of learning and research first. Making cuts to valuable staff while investing millions into buildings in a time of crisis will only make our learning conditions worse. Curtin staff were stretched thin before and these changes will undoubtedly increase that pressure.

Curtin is planning to make the same number of staff redundant as we have seen over the last 5 years combined. Voluntary redundancies threaten the diversity and inclusivity of our university environment, they disproportionately affect women, people with disabilities, queer people and First Nations people.

The Curtin Student Guild stands against cuts to our education. Students, staff and the quality of our education is always on the line when it comes to universities cutting costs, these areas should not face the consequences of Curtin University's poor financial management and prioritisation of capital projects. We will not stand for this.

- Document needs to be clear that processes and structures that are in place in Australia aren't in place on all campuses and that the lack of a formal student representative body is in some case a legislative requirement
- It would be useful to acknowledge the commitment to structured training and development for student representatives
- The roles and responsibilities for both the University and students need to be clearly articulated.

### **Background:**

The Curtin Commerce Club was deregistered due to various problems that were raised by students, particularly around their financial management and conduct.

These issues have affected many Guild members who have not had the benefit of understanding the potential misconduct the took place or have been individually affected without recourse.

The Guild Council has not received any information about the processes that were undertook to deal with these issues or whether any changes need to be made to ensure the good governance of it's clubs and societies are upheld.
