5. Public Question Time. Rob Vusak asked why a motion he put forward for the Guild to condemn Curtin ties to military companies was rejected. The Chair, Veronika Gobba, explained that the motion was rejected because it contravened the decision of the Guild Council. Mitch Craig suggested it was best to submit motions. Rob condemned the statement of 23 May saying there were a number of concerns with it. Curtin did not adequately acknowledge the suffering of Palestinians. Curtin was sponsoring one of biggest weapons conferences in Perth. Rob said that the Guild should acknowledge Curtin's shortcomings Zoe Stevens said that the MOU was not supported by encampment. She asked why there was no more messaging on the Guild's Instagram. Veronica Gobba said that she would check the socials. Zoe said Guild should do more. Veronika said she would take that on notice. Jack Washington asked why had the Guild done nothing since the encampment. Not promoted any protests. Jack asked about the momentum of the campaign. Veronika said that the MOU was the momentum. Ella Marchionda asked about the MOU implementation and asked about the companies on the BDS list. Veronika spoke about working on freedom of information requests and commented that the conference protest was a good idea

Veronika Gobba provided context to the motion. The NUS was required to meet KPIs with a report carried out and assessment recommended by the President. There was discussion about the contribution amount and queries about how much the Guild usually pays and how much other Guilds contributed. There was discussion about whether the NUS had fulfilled its reporting governance requirements. Imari Morris asked what the Guild was getting out of the NUS? Jacquie Bicanic said that the NUS had not contributed to gender-based governance code, it had not done

anything on Palestine or cost of living and there had been no support from the Queer Officer. Mitch Craig said that he had no contact from NUS General Secretary. Veronica noted that NUS governance was poor. Jack Washington said cutting money from the NUS was not the solution that it had a role to play and we should assist make it a better body. There was discussion about alternative use of the funds. Mitch Craig noted that the Guild was hosting the Edcon conference and that amounted to increased funding for the NUS. Veronika asked for a show of hands of those who supported the recommended affiliation fee. The majority of Representation Board members supported the recommended affiliation fee.
