#### **Matters of Representation**

#### **Attacks on Academic Freedom**

I'm very concerned of the concerted push from many universities in this country to implement rushed and blanket restrictions on the rights of students and staff. We have seen concerning recommendations coming out of the parliamentary inquiry into antisemitism at Australian universities which include political interference into research funding and the possibility of a judicial inquiry into these matters, we have seen the attacks on student announcements recently announced at GO8 universities such as UWA and we have seen the Universities Australia definition of antisemitism leave the door wide open for universities to discipline students for criticising Israel and Zionism.

It is important to note that much of this repression is being initiated by the Group of 8 universities but many other institutions are falling in line.

I can't stress enough how disturbing this situation is and how utterly disappointing - but not surprising - it is. Universities need to be bastions of academic freedom. Once we lose this, we will never get it back. It's concerning the speed of which many universities are prepared to throw all of this out of the window, it's not good enough and student unions need to stand up to defend our rights.

The week of the Universities Australia announcement consisted of a strong and concerted effort from myself and the Exec to seek clarification from Curtin University regarding Curtin's plans to implement this definition. On the day of the announcement, I wrote to the Vice Chancellor expressing that the Guild, as outlined in the MOU we signed after the encampment, does and will oppose any policy that silences criticism of Israel and Zionism and impacts on academic freedom. That day, I also expressed the Guild's concerns in-person to the Deputy Vice Chancellor Academic.

The following day, I met with the Vice Chancellor and DVCA and expressed the same sentiments. I am pleased that, during that discussion, the Vice Chancellor confirmed that Curtin does not view criticism of Israel and Zionism as Antisemitic and that Curtin will not discipline any student who engages in criticism of Israel and Zionism along with an expression that students and staff need to be involved in the implementation of any definition. I expressed that it was important that this be placed on the record, for the peace of mind of students who felt under pressure from this announcement and, thus, the Guild published a statement stating our views on this matter and the Vice Chancellor's views and commitments.

I must say that this is very much still a live issue and the Guild must always defend academic freedom for students and staff at Curtin and in all campuses. I am concerned that, at the time of writing, that it appears the Curtin Guild is one of two student unions to make a statement on this issue (props to UTS!) and the NUS has also not made a statement on this. This is a time where freedom of political

communication is under sustained attack and I think it's important that all student unions put aside differences and work together to stand up and fight back.

The speed of which the Curtin Guild was able to secure vital assurances from the Vice Chancellor is in large part thanks to the strength and professionalism of our Guild and was strengthened further by the MOU signed after the encampment which makes clear that the Guild is opposed to policy like this.

We must remain vigilant and we will.

#### **Student Charter Review**

The Vice Chancellor has initiated a review of the Student Charter, which is being led by the Deputy Vice Chancellor (Academic). Initially, I was the only Guild representative set to be represented on the Working Group but, following engagement with the DVCA, was able to secure greater Guild representation (two Student Assist Officers as well as the VPE and VPSW) and an understanding that the university and Guild will work genuinely collaboratively, in the spirit of the Student Partnership Agreement, on this project.

The working group has formed a new sub-group, which has met several times. The Guild wrote the first draft of the new Charter which is now being worked through this process.

#### **Housing Campaign**

The Turn Down the Heat petition has reached over 700 signatures, indicating this is an issue that is pertinent for students in accommodation. We are working on channels of communication with UniLodge to present this petition ahead of launching phase two of this larger campaign.

Reps are currently running BBQ and discussion sessions at accommodations so that students can express concerns or issues they're facing in accommodation which we'll compile and put into a report with recommendations we will advocate for.

Whilst I was in Kalgoorlie, I visited the Agricola student accommodation that Curtin directly operates (not UniLodge - thank god!) and I can't express how nice the facilities are for less than the price of accommodation in Perth (and every room has aircon!). The big issue for accommodation in Kalgoorlie is there simply isn't enough and I'm keen to work with the Kalgoorlie Branch on advocacy around this matter moving forward.

#### **Inquiry into University Governance**

The Guild made a submission into the Senate Inquiry into University Governance. I have attached it at the end of this report for your information.

#### **Guild Operations**

#### Kalgoorlie Branch in 2025

I and Science & Engineering Rep Cooper had a bloody brilliant time in Kalgoorlie working with our incredibly motivated Kalgoorlie Branch Committee. Observations and discussion below;

• **Guild Precinct** | The Guild consists of an office, some storage rooms, a gym, a currently unused kitchen and sub-leases out a bar area to the WASM Social Club. There is a desire from the branch committee to clean up the kitchen and open as a student kitchen and common room, to set up a room as a Women's Room, to consolidate storage, clean up and upgrade the gym (discussed further below) and set up an office space for Student Assist

(discussed further below). There is also a need for refreshed and updated signage to increase awareness of the Guild and update the logos. I'm very confident that these projects can be done in a very cost effective manner and that they will all benefit the students of Kalgoorlie.

- Gym | The Guild Gym in Kalgoorlie is a well utilised space that is included in a tier of
  membership that the branch promotes. Access is hyper affordable at \$15 a month. There are
  some issues with the age of the equipment and the general condition of the room. The
  committee will work with the university to attain a risk assessment, a maintenance plan and
  the implementation of a safety induction for users of the facility.
- Student Assist | There is a lack of knowledge of Student Assist in Kalgoorlie. The Guild used to have a Student Assist Officer based in Kalgoorlie and the campus is keen to explore ways for us to promote our services and programs to Kalgoorlie students. An option that has been canvased includes re-establishing the Student Assist office on campus in the Guild building for officers to use when visiting campus but also as a private space that students can use to videoconference Student Assist. I'm eager to discuss how we can establish this but the campus is happy to assist with this if we decide to go down this path.
- Activities | The committee is eager to explore smaller events they can run in conjunction with their larger events and we will set up a meeting to discuss ideas.
- Representation | The committee is setting up feedback sessions for students to discuss courses with staff. We would be eager to get any information gathered during that process. We also need to make a conscious effort to better engage with Kalgoorlie on academic matters and seek their input and expertise. Ultimately, academic policy is set in Perth so we are still the primary forum for academic advocacy and effective representation
- Governance | The Guild Council will need to decide if it wishes to initiate a review of changes
  to the committee constitution. Of particular concern is regarding the representation of nonWASM students on the Guild (and whether the name should remain the 'WASM Guild' as
  opposed to 'Curtin Kalgoorlie Guild' to better encompass all members) and also building in
  more continuity into the branch where there currently isn't.
- Student Clubs | We need to have more conversations around the governance of student clubs in Kalgoorlie. The university has made it clear that all student clubs need to be Guild affiliated if they are to operate on campus but we need to work through how this will logistically work and be as easy and simple for clubs as possible.
- WASM Social Club | I had a good meeting with the President of the WASM Social Club, Trent. The Guild is committed to backing the Social Club's future as it's an important element of the student experience in Kalgoorlie. With that said, the club is not affiliated with the Guild and the university would like it to be that way if it is to renew our lease over that part of the Guild building in Kalgoorlie. I am eager to work on a way forward that protects the Social Club's identity and its existence.

There are many exciting years ahead for the Curtin Kalgoorlie campus and I'm excited to work alongside the committee to represent them and get the best deal possible for students out there. The increased offering of courses that expand beyond mining is exciting for the region and the campus has the potential to grow into a leading multidisciplinary regional tertiary institution that will make Kalgoorlie a better and stronger place. It's important that students are represented in this process and that students have access to all the support that they need to thrive. The Guild will work to do just that.

#### **Guild Win: Period Product Dispenser Program**

We have secured 50/50 funding with the university for the provision of free period products to students on our campuses up to a maximum of \$15,000 for the year. We have also overcome the

hurdles of the property approvals process at Curtin and have approval for all dispensers to be placed which they will be ahead of this meeting.

It's fantastic that this is now in place and it is a service that will be utilised by many Curtin students for hopefully many years to come.

#### **Guild Win: Clubs Funding**

For several years, the university has approved a \$20,000 grant for the Guild to disseminate to student clubs for events. Unfortunately, the COO had indicated to the Guild that this funding will not be renewed for 2025.

After a concerted effort where I raised this concern at Academic Board and with the Deputy Vice Chancellor Academic, I am pleased to say that the Vice Chancellor has agreed with the DVCA and COO that the funding will remain in place for 2025, which will be welcome news to many clubs and societies.

#### **Food Security & Curtin Community Pantry**

Curtin Volunteers, which has organised the Curtin Community Pantry for several years has indicated that it will be moving to a voucher model (5x \$50 supermarket vouchers a week). The Guild is concerned that this may not meet the demand for food security support at Curtin and I have expressed that the Guild may be interested in taking on the pantry as a student service moving forward. Any further discussion on this will come to Council but I will begin exploring options with Guild Staff and the university. The Vice Chancellor has been made aware of this and I am buoyed by preliminary support for the concept of increased food security programs on campus.

UWA restrictions	The new restrictions UWA has informed its staff and students has been severely concerning. This is part of the international shift seeing freedom of speech stifled in response to foreign policy which Australia shares interest in. This observation is in response to the nature of the restrictions. The meeting at UWA was attended by myself and the Humanities Representative.
Universities Australia: Response	This was covered in depth during the last Representation Board Meeting. In light of the difficult times, I am happy with how the Chancellory has reponded and am pleased they understand the weight of what this means.
Containers for Change deposit	A deposit was made to Containers for Change which saw 400-500 cans/bottles deposited, and around \$40 returned to the Guild.
Student Charter	The Chancellory has determined the Student Charter should be reviewed. A sub-working group with myself and the president has seen us ensure student concerns come first, such as the concern it will be used for disciplinary measures which we have made clear is not something we would stand for. I am happy with how the meetings/drafts have progressed and believe student representation is especially important on this.
Meetings with Equity Reps	I have moved from meeting with equity reps based on need/request, to setting weekly meetings. This has helped with efficiency.

#### **FBL Learning and Teaching FCC**

I was unable to attend the FBL Learning and Teaching FCC as it occurred during my class, along with this I had reached out to the FCC for my apologies and future apologies as I will be unable to attend for the remainder of Semester 1 due to my class, and will have to get a rep to attend on my behalf until the class concedes. I have made an agreement with Ben (VPE) on attending on my behalf when I am unable to do so.

#### **Invigilation Concern Meeting over transition from IRIS to Respondus**

Lorien and I received an email on the  $4^{th}$  of February from a Law student currently completing trimesters, raising concerns over the implementation of the invigilation software 'Respondus' set to replace 'IRIS'. The email in summary explained:

- Respondus wouldn't allow students to access electronic notes during open book tests.
- This would cause students who have write their notes online, to print all notes and relevant cases.
- Leads to sustainability issues regarding amount being printed and printing costs
- Accessibility concerns over how Respondus would affect those using CAP plans and if it would be able to give them the support they need.

Lorien reached out to the accessibility department and found that:

- Respondus isn't intended to be used for open booked exams or tests and is to be used for close booked or limited book
- Lecturer should be able to add relevant documents for students to access
- OAR also advised that students with queries about Respondus should email respondus@curtin.edu.au

With this it was decided that Ben as VPE would reach out to Dylan to ask the Pro-Vice Chancellor:

- Clarification if respondus is not to be used in open book
- How was respondus introduced to students as students concern doesn't align with our info
- How does respondus work with CAP plans

#### FBL Let's Explore Wadjemup Rottnest Trip:

Volunteered as a student leader for the FBL Let's Explore Wadjemup Rottnest Trip for International FBL students studying at Curtin. Day started early at Curtin where a bus transported the students to Fremantle for the ferry over. I was partnered with Jenna (FBL staff) to lead and overlook a group of 9 international students. Every student in our group was from Europe with most being from Germany. It was great that I had recognised some of these students from O-Week and they also recognised me. We were able to have many discussions regarding questions they had about WA and related to Curtin which I was able to help with. This trip also strengthened my relationship with some of the FBL clubs as some clubs joined on the trip as other student leader volunteers. Overall, it was a successful day of engagement with students, clubs and staff. I also documented the day to create a reel summarising it for the FBL Guild Instagram account.

#### **Interfaculty Event Planning:**

There was an initial plan of having a sports carnival-esque interfaculty event which was cancelled as the Curtin Stadium already planned something similar. With such we pivoted and decided to complete a scavenger hunt. This meeting went through the details of this event including what activities would be done, locations, time, date etc. The meeting ended with a great understanding of the day and there was little left to go over/decide on which was sorted out via emails amongst the relevant members. The event is now in the process of coming to life with myself overseeing organising the WhatsApp community and group to be used on the day. I am still involved in other aspects of the event but that is my main duty during this early stage.

#### **Assessment Feedback Meeting & Planning Session:**

Discussed Jon Yorke's Email detailing the changes to the Assessment and Student Progression Manual (ASMP) and discussed the Draft sent in with these changes. Changes that were of note include:

- The removing of incremental assessments and limiting number of assessments: This change was found to be unnecessary with it causing a more negative impact rather than positive.
- Adding a new academic status (Good Standing, Conditional, Terminated): This was discussed
  with the conclusion that adding an 'At Risk' or Framework after losing Good Standing and
  before Conditional would be beneficial. This status would include:
  - Students having a meeting with a wellbeing staff and discussing the cause of this change.
  - Being provided with the resources relevant to the cause after the discussion.
  - Being more proactive and intensive when working with First Year students in this status due to their new nature.

- Assessment Quality Process (AQP Procedure) was completely taken out and no explanation was provided.

Overall, the meeting was great at discussing and analysing the new changes of the ASMP.

#### **Updates**

#### Social Media KPI:

I have been active on social media via posting any upcoming events or surveys through stories or as posts. The main source of my increase in followers on Instagram is through being invited as a collaborator by clubs on their posts regarding events. This gives a mutual benefit as they can reach the guild followers, and I can reach the feed of their followers. Facebook has been rather stagnant in activity as many of the members have moved to the Instagram account, but events are still shared on Facebook for those students without an Instagram.

#### **Essential Textbook Campaign:**

From the meeting at the beginning of the year, the processes the LITEQ team have implemented show this campaign to be a success. To confirm that this campaign is complete I am reaching out to the LITEQ team about the results on their end.

#### Survey:

#### **Bachelor of Electrical and Computing Major not seeking accreditation:**

Curtin and the Faculty of Science and Engineering received advice from Engineers Australia that if they were to pursue accreditation for the Electrical and Computer Engineering Major, it would be unlikely to receive accreditation. As such Curtin decided not to pursue

accreditation.

In order for students to have a fully accredited qualification, Curtin is seeking to transition all students to the Electrical and Electronic Engineering Major.

This decision affects 217 students, with four cohorts of varying risk levels:

Cohort A (122 Students), Cohort B (63 Students), Cohort B+ (24 Students), and Cohort C (7 Students), with Cohort A being at the lowest-risk for disruptions to their studies, and Cohort C being the highest.

High risk students have been contacted and are getting personal support from the Dean of Learning and Teaching and the Course Lead. Lower risk students will have access to support through a dedicated email contact and Teams site.

A town hall was held on the 26<sup>th</sup> of March for all students affected, which myself and Myles from Student Assist attended. The town hall outlined the problem, and the solution the faculty came up with. It also allowed students an opportunity to ask questions and voice their concerns about the situation.

This situation is not good for students who already have a lot on their plate without the added stress this may cause, but the faculty staff are focused on ensuring students are able to graduate on schedule with an accredited degree.

#### **Course Lead (Natalie Lloyd) Report:**

Discussed visits to international campuses. Reminder to include Miri in course and curriculum discussions.

Spoke about the pre-orientation Women in Engineering event, and how positive the event was for everyone involved.

Spoke about ENGR1002, a new unit that has students working on real industry problems, no lectures, very real world focused.

Discussed MJRH-ECENG. Brought up a point that the "And" in the name of a course/major has serious importance and should not be added without proper backing that the major can provide enough coverage of X <u>AND</u> Y to show a student is proficient enough to be accredited as both.

The assessment feedback campaign has been interrupted by proposed changes to the Assessment and Student Progression Manual (ASPM), which has become our priority focus in the area. It is entirely likely that the limit of three assessments per unit may be removed, along side a variety of other changes, good or bad. Addressing these changes is highly important and we will continue to have discussions on the matter. A meeting to discuss the assessment feedback campaign generally is still on the table but will only be focused on once the ASPM is sorted.

#### Education:

Great progress is being made on the issues in the School of Education, largely due to new Directors of Learning and Teaching. I have been in regular contact with the 2 DLT's regarding issues brought to my attention, and these issues have been well addressed. The Curtin Education Students Society continues to grow and be active, and I believe that their influence is a positive community factor in the school. Issues regarding the Bachelor of Educational Studies seem to be going in the right direction as the course co-ordinator has now returned (It was previously run by an acting co-ordinator, who also ran Primary Education). #### **Higher Education Report Rep Board Meeting April**

### Election 2025: Bipartisan blast as universities cry foul over foreign student cuts. The Australian

Cash-strapped universities have accused both sides of politics of a "race to the bottom" in slashing international student numbers.

Universities Australia chief executive Luke Sheehy said the Coalition was "stoking anger in the electorate" while Labor was "caving in to protect its vote".

"It's officially a race to the bottom," he told the Independent Tertiary Education Council conference in Adelaide on Wednesday. "Both sides (are) deferring blame for their own domestic policy failures in office.

"The Coalition had been beating this drum for months, blaming international students for driving up (rental) prices and locking Australians out of the market.

"We know from polling that migration and housing are hot-button issues. Cue Labor's knee-jerk response, and in one fell swoop, international students became scapegoats for Australia's housing crisis."

The federal government is relying on a ministerial directive to slow the processing of student visas, after the Coalition torpedoed Labor's legislation last November to cap numbers at 270,000.

Peter Dutton has promised even deeper cuts, but has failed to explain how many foreign students would be allowed into Australia, or how a Coalition government would manage enrolments based on nationality, institutions or destinations.

Mr Sheehy said if the Coalition froze foreign student numbers at 2023 levels, universities would have to shed nearly 55,000 international students. "Imagine torching \$4bn in revenue at a time our economy and our sector can least afford it," he said.

"International education is our nation's biggest export outside of mining. It generates \$52bn each year, it pays for essential services, it supports 250,000 Australian jobs, it funds vital university research and it subsidises the education of Australian students.

"That's why it's crazy to even think of curtailing this vitally important sector, particularly now."

Mr Sheehy said international students accounted for just 6 per cent of the national rental market.

He said both major parties had encouraged the growth in international students for more than a decade, and went to "great lengths" to encourage their return after the Covid-19 pandemic.

"Universities, on average, bank around \$30,000 per international student enrolled," he said.

"Universities have grown heavily reliant on this revenue to cover commonwealth funding gaps. That's money that helps fund teaching for Aussie students and research. Both major parties are biting the hand that helps fund our sector."

Mr Sheehy said he had sought a meeting with the federal Opposition Leader to explain his plans.

Coalition campaign headquarters would not tell The Australian whether Mr Dutton would make time to meet Mr Sheehy.

The Australian revealed on Wednesday that the number of student visa applications halved in January this year, compared to last year, with applications in February similar across both years.

#### Election 2025: International student '30pc flat caps to cost \$4bn'. The Australian

The peak body for universities says a proposal to cap international students could cost the economy \$4bn and cut almost 55,000 students.

Amid speculation that the Coalition may adopt a flat percentage cap on international students as part of its federal election platform, Universities Australia chief executive Luke Sheehy has warned that such an approach would inflict significant damage to the \$52bn sector and to the economy.

Mr Sheehy will use his keynote address at an ITECA conference on Wednesday to urge the Coalition against adopting a flat percentage cap as its official policy to slash international student numbers in a bid to cut net migration.

UA predicts that restricting international student numbers to 30 per cent of enrolments would cut 54,577 students, limiting numbers to 33 per cent would reduce enrolments by 37,503 students and a 35 per cent cap would reduce students by 28,534 students.

The modelling, based on 2023 enrolment numbers, revealed that capping foreign students to 30 per cent would inflict a \$3.96bn economic hit, restricting to 33 per cent would cost \$2.72bn and a 35 per cent scenario would cost \$2.07bn.

Mr Sheehy will address speculation the Coalition is considering a 30 per cent cap, cautioning against adopting further measures that would cut university funding.

"What we stand to lose in future revenue is far greater," he will say.

"This all begs a few questions. Is this all worth a few votes at the ballot box? Is this all worth the economic hit?

"Is this all worth inflicting financial pain on universities?"

Mr Sheehy will also call on whichever party wins the election on May 3 to plug the funding shortfall once covered by revenue generated by international education. "The boom in international education has papered over these cracks," he will say.

"But the revenue this oncereliable source provided is no longer guaranteed. Universities Australia has been calling for full and proper funding for our sector in light of this."

A 35 per cent flat cap on internationals students was also estimated to cost institutions \$1.6bn directly. International students enrolled at universities contribute \$72,600 to the economy on average, with \$30,200 going directly to providers.

The Australian revealed last month that the Coalition had been consulting on a range of options to cap international students, including a proposal to cap overseas students at a percentage of total enrolments.

Another approach canvassed was to cap foreign students to a percentage below a previous year's enrolments.

The Coalition has promised to pursue steeper student caps than Labor but is yet to unveil details of its policy platform.

Liberal frontbenchers have previously said they wanted to target metropolitan universities, especially in Sydney and Melbourne, while seeking to bolster foreign student numbers at regional providers.

The Coalition torpedoed Labor's legislation capping international students to 270,000 in November over concerns the framework was "chaotic and confused", vowing to unveil its own policy in due course.

The Australian Technology Network of Universities floated a proposal in July for a flat cap of 35 per cent of total enrolments.

#### New Regional University Study Hub for Katanning. Jason Clare media

A new Regional University Study Hub opened to students this week at Katanning, bringing university closer in regional Western Australia.

Nearly half of young people in Australia have a university qualification but not in regional and remote Australia. In Katanning, only 12.9% per cent of young people have a degree.

Regional University Study Hubs are one of the ways to change this. The evidence shows that where they are, university participation goes up.

This new Study Hub in the centre of Katanning, will provide student support and facilities for students who are studying a university or TAFE course without having to leave their community.

The new Katanning University Study Hub is part of the Albanese Government's \$66.9 million investment to double the number of University Study Hubs across the country.

The hub will be operated by Regional Development Australia Great Southern who operate the existing Great Southern Universities Centre in Albany which has supported over 400 students since opening.

So far, the Katanning Study Hub has 12 registered students. Katanning is one of Western Australia's most multicultural regional areas.

There are now 56 Regional University Study Hubs <u>located</u> across the country.45 of these Hubs are open with the other 11 Hubs expected to open during 2025.

This builds on the recent announcement for 15 Suburban University Study Hubs, located in the outer suburbs for the first time.

This is one of the ways the Albanese Labor Government is helping more people get a crack at going to TAFE or university, including:

• wiping \$3 billion in student debt from around three million Australians

- cutting a further 20 per cent off of all student loans if re-elected, wiping around \$16
   billion in student debt
- introducing a Commonwealth prac payment for teaching, nursing, midwifery and social work students
- making free TAFE permanent.

### Pocock accuses ANU leadership of misleading Senate estimates after paying consultant more than \$1 million. ABC

In short:

David Pocock is calling for an investigation, alleging ANU leadership misled a Senate estimates committee about the cost of an external consultant contract.

ANU said the statement to estimates was factual.

What's next?

The Senate committee will consider what action, if any, they will take.

Independent Senator David Pocock has accused the Australian National University (ANU) of misleading a Senate estimates committee over how much it paid to a consulting firm.

The ANU engaged Canberra-based Nous Consulting Group last year to aid in the institution's restructuring as it aims to save \$250 million by the end of 2026.

During Senate estimates on November 7, ANU chief operating officer (COO) Jonathan Churchill told the committee the university had "paid circa \$50,000 this year" to Nous.

However, in responding to a question on notice, ANU said the original contract, signed in September, was worth \$837,000 for a 12-week period.

The written response said the contract had twice been extended, at an additional cost of \$290,000.

Mr Pocock said he was "appalled" the leadership of the ANU had appeared to show such contempt for the Senate estimates process.

"They must've known that when they said that to the committee."

Mr Pocock said he had written to Labor senator Tony Sheldon, chairman of parliament's Education and Employment Legislation Committee, requesting an inquiry into ANU and its apparent contempt for parliamentary process. He also wrote to the ANU Vice-Chancellor Genevieve Bell asking for an explanation.

National Tertiary Education Union ACT division secretary Lachlan Clohesy said questions had to be asked why consultants were being hired to address specific skill deficiencies in the staff when there were so many ANU staff on significant salaries.

Students and union groups concerned by Coalition's 'woke' agenda education crackdown. ABC

#### In short:

A Coalition crackdown on "woke" ideology in schools and universities has raised concerns among students and union groups.

Opposition Leader Peter Dutton earlier this week flagged putting "conditions" on state school funding to prevent "indoctrination" in the classroom.

What's next?

Labor is warning schools will face funding cuts under a Coalition government.

Students and union groups fear the Coalition's crackdown on "woke" ideology in schools and universities could threaten freedom of speech.

Opposition Leader Peter Dutton has offered little detail about his plan to fight "indoctrination" in schools, but <u>signalled cuts to "wasteful government spending"</u> within the federal education department if elected.

National Union of Students (NUS) president Ashlyn Horton said she feared Mr Dutton was "trying to target reconciliation" with First Nations Australians.

"All progressive movements we've had in this country in the past term of government, he's tried to completely push back," she said.

Adrian Murdoch is the acting CEO of the Minus 18 Foundation, which delivers inclusion training for education staff to support LGBTQIA+ students.

While it's unclear what the Coalition would target in its "woke" agenda blitz, Mr Murdoch said he feared inclusion training could be on the list.

"It's a real slap in the face for the parents of the two-in-three LGBTQI+ young people who still experience discrimination," he said.

"I think Australians really want schools that are safe and welcoming."

National Tertiary Education Union national president Alison Barnes linked the Coalition's position to <u>US President Donald Trump dismantling the US Department of Education.</u>

"Every Australian should fear the prospect of Peter Dutton deciding what does and does not get taught in schools and universities," Dr Barnes said in a statement.

The Coalition's education spokeswoman Sarah Henderson declared a Dutton government would "take action" if elected, raising concerns about how universities are training teachers.

Senator Henderson said the Coalition would "leave no stone unturned" and use existing powers to request the Tertiary Education Quality and Standards Agency (TEQSA) make recommendations about the quality of higher education providers to ensure students were put first.
